The **Forensic Personality Disorder Service** was developed to provide specific assessment and treatments for men diagnosed with personality disorder and who are also considered a risk to themselves or others. My role was chartered clinical psychologist in a multidisciplinary team.

At **St Nicholas Hospital** there is a 16 bed medium secure unit and a community outreach service that works with men in the northern region (UK). My position was split between these services.

The **SBU** is a partnership between the Northumberland, Tyne and Wear NHS Trust, Adult Forensic Psychiatry Department, the National Probation Service, Northumbria and Barnardos Mosaic Project. The SBU provided assessment and treatment of adults who may pose a risk in relation to sexually abusive behaviour. I was one of a core group of professionals that responded to referrals. My involvement included completing sex offender risk assessment reports for court (criminal and family). I was also involved in the facilitation of a learning disabled sex offender treatment programme for 12 months.
